Beginning October 11, 2025, the Centers for Medicare & Medicaid Services (CMS) will begin issuing Civil Monetary Penalties (CMPs) for Section 111 reporting errors. Fines can reach over \$500,000 per violation, with errors as minor as late submissions.

Despite the high stakes, many Responsible Reporting Entities (RREs), which include workers' compensation carriers, self-insureds, liability and no-fault carriers, won't know they're non-compliant until it's too late.
